1. OPENING

Regional Chair Valeria Magistelli opened 27th European Conference by welcoming everyone and thanking them for their presence. She especially noted those participants visiting from outside Europe. She also mentioned that this is the second European Conference in Poland. The first was held in 1997 in Gliwice. She welcomed her colleagues on the European Executive Committee.

2. ENUMERATION OF PARTICIPANTS

Regional Chair Valeria Magistelli enumerated the participants and the voting delegates. Twenty chapters with vote were present. This meant that 11 votes were necessary for simple majority and 14 votes for a 2/3 majority decision.

3. ALLOCATION OF NATIONAL VOTES

We currently have five countries with more than three chapters. They are Albania (5), Bulgaria (5), Poland (5), Romania (5), and the Ukraine (10). None of these countries had more than three chapter present. Thus all could vote.

4. DESIGNATION OF A PARLAMENTARIAN

Presiding Chair designated Stuart Exell, PTPI's Chester, England Chapter, as parliamentarian to advise the Chair. Stuart accepted the task at hand.

5. MINUTES OF THE PREVIOUS MEETING

Secretary Rolf Dahlberg summarized the minutes from the last European Conference in Pécs, Hungary in 2010.

She was elected to the EEC for a two year term. Olga Sirbu from PTPI's Chisinau, Moldova Chapter was re-elected for a new one year term.

10. NEW BUSINESS WITH AMONGST OTHERS

A. Report - European Organisation by the Regional Chair. Valeria Magistrelli spoke of the European Organization at large and some of the past year's activities. The Regional Chairs Report was approved.

B. Report - Financial Conditions by the Treasurer. Made by treasurer Hannelore Büchler. The report was approved.

C. Report - Auditors. The report by the auditors was read by Lars Poignant and approved.

D. Report - Public Relations Officer. PR Officer Antoinette McInryre-Andersson could not unfortunately attend the conference.

E. Report - Youth Coordination Officer. The YCO Sorina Danciu could unfortunately not attend this conference.

F. Reports from Representatives of National Organisations and Chapters.

The chapter reports were split into two parts:

- a. Karina Tatarova from of the Plovdiv Student Chapter, Andrei Coduneau of the Roman, Romania Chapter and Anne Marie Bohsen from the South Denmark Chapter gave reports to the whole council meeting
- b. Chapter fair (after lunch)

For the fifth time during a council meeting a fair was used as chapter presentation. Each chapter had the possibility of putting up pictures and posters from their home community. Many served both food and offered something to drink specific to their region. This was a much appreciated way of giving chapter reports.
